Critiques:

Jennifer presented work in progress, embroidery of bees in various sizes. The piece is an extension of her earlier installation about vanishing bees and had questions about whether the embroidery hoops speaks of hives and whether the sketches and embroidery communicate the vanishing bee crisis well enough. Comments: Have the hoops displayed in progression of many bees to fewer bees

Try tea stained background, Use encaustics, Use hexagonal frames, and embroider unhealthy and deformed bees.

Beth brought back the Citi Fleurs, a welded steel rods sculpture with various balls with patterns, as flowers on them. All agreed that the patina as well as the added curves on the steel rods made a much more cohesive piece. Other comments about the piece: playful, whimsical and happy. She will have total 11 of these pieces at the Walnut Creek Ruth Bancroft Garden.

Treasurer's Report: F/D account has \$5366.65 in the bank after the donation to MCD. Juline wanted a guideline what and how the reimbursement should be made. The members agreed that any expenses incurred for a specific show should be submitted to the designated chairperson so s/he can submit the compiled total to Juline.
